CALLS FOR PROPOSALS

Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

Women TechEU – Second Open Call

The Women Tech EU project's main goal is to empower women founders and entrepreneurs who lead deep tech start-ups in Europe. Participants will have the opportunity to receive 75.000€ and access a customised business development programme.

Water4All 2024 Third Joint Transnational Call

The Joint Transnational Call (JTC) is launched in the framework of the European partnership <u>Water4All</u> and supports research and innovation projects to improve long-term water security. The main theme of this call is "Water for Circular Economy". Proposals are required to address at least one of the following themes:

- Topic 1: Enhancement of water circularity in industries;
- Topic 2: Urban water circularity;
- Topic 3: Resource recovery and valorisation;
- Topic 4: Economic, environmental and social implications of water reuse and recovered products.

Funding programme: Horizon Europe - MUR

Call & Topic ID: HORIZON-CL6-2021-CLIMATE-01-02 - European Partnership Water Security for the Planet (Water4All)

Deadline: November 13th 2024

Applicants: participants are subject to the eligibility criteria of national/regional funding organisations **Activity sectors:** water resources management

Partnership: required (at least 3 eligible partners that request funding from participating Funding Partner Organisations from 3 different countries)

CASCADE FUNDING

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

fuTOURISME Open Call for Innovative Projects in Tourism

This call aims at identifying and supporting the development, implementation and scaling-up of innovative solutions (products, processes, services and/or business models) by European tourism SMEs (or partnerships), to contribute to innovating the tourism ecosystem and enhance the twin transition. The call will support 60 innovative projects with a lump sum of $30.000 \in$.

Deadline: November 27th 2024

Applicants: tourism SMEs established in Cyprus, France, Greece, Italy, and Spain.

Activity sectors: tourism

Partnership: optional (single applicants or consortia of minimum 2 and maximum 4 partners)

6G-BRICKS 2nd Open Call

The objective of the call is to select projects for the roll-out of 3rd party experiments on 6G-BRICKS experimental infrastructure to validate its capabilities, functionalities and performance in extended domains (e.g., PPDR, media, eHealth, transportation, Industry 4.0).

Deadline: December 23rd 2024

Applicants: SME and/or Big Company and/or RTO established in EU Member States or Horizon Europe associated countries

Activity sector: 6G infrastructures and technologies

Partnership: required (consortia of up to 2 legal eligible entities)

Chips Joint Undertaking (JU) Quantum Technologies calls for proposals

These new calls for proposals, launched in the framework of the Chips JU, aim at developing a scalable production infrastructure for trapped-ion quantum computing processors in Europe, transitioning from manually fabricated ion traps to automated manufacturing processes. The aim is to support one pilot line implemented through a Framework Partnership Agreement between the Chips JU and consortia of industry, research organisations and the institutions in Quantum Technologies.

Call & Topic ID: Framework Partnership Agreements for developing Quantum Chip Technology for stability Pilots (HORIZON-JU-Chips-FPA-QAC)
