Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli <u>obiettivi politici</u> della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche **call for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

Single Market Programme: call for proposals for social economy enterprises

This call for proposals in the field of social economy under the Competitiveness of Enterprises and SMEs strand of the Single Market Programme (SMP COSME) comprises two topics:

- Topic 1: <u>SMP-COSME-2024-SEE-01</u> <u>Stepping up organisational and entrepreneurial capacity of SMEs in social economy</u>. Budget: 6.000.000 €; indicative number of grants: 3-4.
- Topic 2: <u>SMP-COSME-2024-SEE-02</u> <u>Partnerships for circular value chains between mainstream businesses and SMEs in social economy</u>. Budget: 2.000.000 €; indicative number of grants: 2-3.

European Biodiversity Partnership: 2024-2025 Joint Call

The BiodivTransform Call aims at supporting interdisciplinary, transdisciplinary, and/or cross-sectoral research and innovation projects to 1) help understand trade-offs and cross-linkages between the worldwide crises of biodiversity loss, climate change, and pollution; and 2) identify, analyse, and comprehend transformation processes that may safeguard biodiversity. The Italian Ministry of University and Research (MUR) will fund up to 10 projects with up to 150.000 €/each.

Deadline: Pre-proposal November 8th 2024 | Full proposal April 11th 2025

Connecting Europe Facility: 2024 Transport calls for proposals

The 2024 CEF Transport calls for proposals make €2.5 billion available to build and modernise European transport infrastructure in the framework of the <u>Trans-European Transport Network (TEN-T)</u>, addressing railways, inland waterways (IWWs), maritime and inland ports, road safety, multimodal freight terminals, multimodal passenger hubs, smart and interoperable applications for transport, safe and secure mobility infrastructure resilience. The calls cover the core, extended core, and comprehensive TEN-T networks in the following topics (27 sub-topics):

- Projects on the Core Network: CORECOEN
- Projects on the Comprehensive Network: COMPCOEN
- Smart and interoperable mobility: SIMOBGEN and SIMOBCOEN
- Sustainable and multimodal mobility: SUSTMOBGEN
- Safe and secure mobility: <u>SAFEMOBGEN</u> and <u>SAFEMOBCOEN</u>

CASCADE FUNDING

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle

tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

Future Technology Days open innovation challenge

French large company from the aerospace and propulsion sector launched the Future Technology Days open innovation challenge. The company is proposing 33 technical challenges, in the following 8 domains: thermal & mechanical products, propulsion, avionics, functional & ground equipment, data in production, manufacturing, assembly integration & test, and supply chain. Al REDGIO 5.0: 2nd Open call for innovative experiments

Al REDGIO 5.0. aims at reinforcing the alliance between Vanguard European Initiative and EDIHs for the Al-at-the-Edge adoption by European manufacturing SMEs. The 2nd open call will support up to 10 SME-driven experiments, focused on implementing Al-at-the-Edge and industry 5.0 systems with the aim of improving existing solutions, products, or processes in the manufacturing area. Total call budget: 600.000 €; up to 60.000 €/SME. The experiments are expected to cover 2 topics:

- TOPIC 1: Al-at-the-Edge convergence between Data and Al continuum, Cloud, Edge, IoT technologies;
- TOPIC 2: Industry 5.0 Human-Centric and Sustainable-Circular Manufacturing, inspired by WISE principles.

Applicants: manufacturing SMEs from EU member states or Horizon Europe Associated Countries

Activity sector: artificial intelligence, industry 5.0

<u>CircInWater Internationalisation lump sum 2nd round</u>

CircInWater, the Water-Smart Eurocluster project funded by the EU, aims at supporting European SMEs to develop and implement water-smart solutions for the agri-food and energy-intensive industries (EII). This call aims at providing internationalisation opportunities in Canada and the USA by granting between 20 and 25 SMEs with a financial support of a maximum of 2000 €/each.

Deadline: February 12th 2025

Applicants: European SMEs offering water-smart solutions for the agri-food and EII industries
